The Services Contract will include the following:

- Provision of scaffolding erection, inspection, approval, and dismantling in accordance with international safety standards.
- Development and implementation of height work risk assessments, safety plans, and fall rescue procedures
- Supply and management of scaffolding materials (250 tonnes total) and related equipment
- Deployment of qualified personnel including Site Manager, Supervisors, Inspectors, Erectors, SHER Officer, and First Aider

- **The duration of the Services Contract is estimated to be twenty-four (24) months, comprising:**

- Mobilisation and planning period of up to four (4) weeks following contract award
- Twenty-four (24) months of scaffolding management services across both power stations

- The Procuring Entity is **Botswana Power Corporation, Generation**

- Procurement Method is: **Open Domestic Bidding, restricted to 100% citizens**
