• **TENDER 7703/26 PRE-QUALIFICATION OF CONTRACTORS FOR THE EXECUTION OF UNIT 2 BOILER AND ITS AUXILIARIES MAJOR OVERHAUL (MOH) WORKS AT MORUPULE B POWER STATION**

- Botswana Power Corporation (BPC) invites suitably qualified, experienced, and capable bidders to submit Expressions of Interest (EOI) for pre-qualification for the execution of Unit 2 Boiler and Its Auxiliaries Major Overhaul (MOH) works at Morupule B Power Station (MBPS).
- The works comprise highly specialised inspection, maintenance, refurbishment, testing, and commissioning activities on critical boiler systems, including boiler pressure parts, steam and water circuits, superheaters, reheaters, economisers, air preheaters (APH), draught fans, ducting systems, coal handling systems, and associated auxiliaries.
- This EOI is issued as a standalone procurement process, independent of any existing Operation and Maintenance (O&M) or Service Level Agreements (SLA) currently in place at MBPS.
- The objective of this EOI is to identify and shortlist bidders with demonstrable technical capability, relevant experience, and adequate resources to execute complex boiler and auxiliary system overhaul works in accordance with Original Equipment Manufacturer (OEM) requirements and applicable international standards and best engineering practices.
- Only bidders that meet the minimum pre-qualification requirements and demonstrate proven capability in similar large-scale power generation projects will be considered for the next stage of procurement.
- Bidders are encouraged to incorporate local participation, and skills transfer in their approach, including the utilisation of locally registered subcontractors and the development of local technical capacity.
- The purpose of this EOI is to:
 1. Pre-qualify technically competent and experienced bidders capable of executing the Unit 2 Boiler and Auxiliaries MOH works at MBPS;
 2. Identify bidders with proven experience in boiler pressure parts, high-temperature systems, auxiliary equipment maintenance, and outage execution in high-risk, high-reliability environments;
 3. Establish a shortlist of qualified bidders to be invited to participate in a subsequent competitive procurement process; and
 4. Ensure that only bidders with the required technical expertise, financial capacity, and operational capability are considered for this critical outage project.
- This EOI constitutes a strict pre-qualification process and shall serve as a gatekeeping mechanism to eliminate non-compliant or technically unsuitable bidders.
